

InterDev Ranked No. 84 in Atlanta on 2013 Inc. 5000 List of America's Fastest-Growing Private Companies

Alpharetta, GA, September 13, 2013 -- *Inc.* magazine today ranked InterDev, an Atlanta-area provider of information technology and security services, No. 2206 on its 32nd annual Inc. 500|5000 list -- an exclusive ranking of the nation's fastest-growing private companies. InterDev was ranked 84 on the list among Atlanta companies and 4th among IT Service Providers nationwide.

"Public-Private Partnerships with cities in Metro Atlanta have been integral to InterDev's growth during this period," said InterDev CEO Gary Nichols. "Since 2010 we've helped numerous newly formed cities come online faster through municipal IT outsourcing."

At the same time that InterDev was growing their PPP practice and staff, they were also capitalizing on the demand for better security across the public and private sectors. "Investments we made in personnel, training and partnerships have helped to attract more interest from our core base of mid-market customers," continued Nichols.

The list represents the most comprehensive look at the most important segment of the economy—America's independent entrepreneurs. Companies such as Microsoft, Zappos, Intuit, Jamba Juice, Zipcar, Clif Bar, Vizio, Oracle, and many other well-known names gained early exposure as members of the Inc. 500|5000.

"Not all the companies in the Inc. 500|5000 are in glamorous industries, but in their fields they are as famous as household name companies simply by virtue of being great at what they do. They are the hidden champions of job growth and innovation, the real muscle of the American economy," says *Inc.* magazine Editor Eric Schurenberg.

The 2013 Inc. 500|5000, unveiled in the September issue of *Inc.*, is the most competitive crop in the list's history. The Inc. 500|5000's aggregate revenue is \$14.1 billion, with a median three-year growth of 1,739%. The companies on this year's Inc. 500|5000 employ more than 52,100 people and generated over 44,912 jobs in the past three years. Methodology

The 2013 Inc. 500|5000 is ranked according to percentage revenue growth when comparing 2009 to 2012. To qualify, companies must have been founded and generating revenue by March 31, 2009. They had to be U.S.-based, privately held, for profit, and independent—not subsidiaries or divisions of other companies—as of December 31, 2012. (Since then, a number of companies on the list have gone public



or been acquired.) The minimum revenue required for 2009 is \$100,000; the minimum for 2012 is \$2 million. As always, Inc. reserves the right to decline applicants for subjective reasons.
